DISTRICT OF SECHELT Sewer User Fees Amendment Bylaw No 426-20, 2025

A bylaw to amend Sewer User Fees Bylaw No. 426, for the District of Sechelt

WHEREAS the Community Charter, SBC 2003, c 26 provides that a Council may by bylaw impose a fee payable in respect of all or part of a service of the municipality;

AND WHEREAS the Council of the District of Sechelt deems it necessary to amend the fees for sewerage usage;

NOW THEREFORE, the Council of the District of Sechelt in open meeting assembled enacts as follows:

TITLE

1. This bylaw may be cited for all purposes as, "Sewer User Fees Amendment Bylaw No. 426-20, 2025".

DEFINITIONS

2. In this bylaw:

Council means the municipal Council of the District of Sechelt. **District** means the municipal corporation of the District of Sechelt.

PROVISIONS

3. 'Schedule A' of District of Sechelt Sewer User Fees Bylaw No. 426, 2004 is deleted and replaced with the 'Schedule A' attached to and forming part of this bylaw.
